Selection Committee Minutes – 16 June 2021

Background

Pursuant to the resolution of State Council in February 2002, the WA Local Government Association Selection Committee was established to oversee the selection process for Local Government vacancies on boards and committees.

The Selection Committee conducts a merit-based and transparent assessment process encompassing the principle of "best person for the job". Upon completion of the assessment of nominations for vacancies, the Selection Committee either endorses preferred candidates for appointment (under delegated authority) or makes advisory recommendations to State Council for ratification of preferred candidates.

The Minister for Local Government formally requested WALGA to recommend a panel of nine Local Government Elected Members for consideration to be appointed as Member and Deputy Member to the Local Government Advisory Board. The vacancy is due to the incumbent's term having expired and it was acknowledged by the Selection Committee that the position is notionally a country member position.

Background

Minutes of the LGIS Board meeting held on 13 May have been distributed to the members of the State Council under separate cover.

Items of note from the minutes include:

 The Board adopted the LGISWA budget for 2021-22, noting that the JLT and WALGA fees are subject to the new Agreements with WALGA and State Council approval. The budget includes in-house claims management for Motor Fleet cover.



- The Board approved the remaining provisions previously set aside for distribution back to Members (\$2.5M) be credited off Members Scheme membership contributions for 2021/22.
- The Board approved commutation of the AIG primary layer for the LGIS Liability indemnity of \$1.96M for the 2011/12 and 2012/13 fund years back to Scheme. This has runoff cover by QBE to protect the Scheme against the costs of any future claims for those fund years.
- The Board approved of the application of Reserve Funds, including a Pilot Fleet Risk Management Project of \$130,000 for the new Motor Fleet cover.
- The Board received the Scheme quarterly financial report for the period ended 31 March 2021.

Executive Summary

As directed by State Council in September 2019, WALGA engaged a consultant to review the efficacy and value for money of the LGIS Risk Mitigation Services.

The review:

- Found that the programs are generally effective and deliver value for money.
- Identified some recommendations that may enhance the LGIS risk mitigation services.

The report was presented to the LGIS Board on 1 July. WALGA and LGIS Management are tasked with identifying actions for each of the review recommendations.

Background

This item reports to the following State Council review option for the LGISWA Scheme arrangement.

State Council Resolution 108.6/2019, 6 September 2019:

Item 5.16 Option 3 - Undertake Review of Risk Mitigation Services

SUPPORT allocate WALGA budget 2020/21 for an independent review of the appropriateness of the scope; alternative delivery models; and effectiveness of the risk mitigation services.

Comment

The key findings of the review are that:

- The claim trends support that the risk mitigation programs are effective;
- The LGIS claim number and costs trends have similar or more favourable outcomes than data from APRA and WorkCover WA;
- A substantial increase in program hours in one year leads to a net decline in claim costs in the follow year, however this does not hold true over a 2-4 year period (suggesting other issues are influencing long-term claim trends);



- The allocation of program hours, in general, appears to be allocated appropriately across members based on their respective claim numbers and claim value;
- The spend for risk mitigation services across the WA population bands is appropriate;
- The spend for risk mitigation services is appropriately allocated in a greater proportion to those Local Governments with larger claim values;
- The spend on risk mitigation services as a proportion of total contributions is appropriate when compared against LGASA;
- The reinsurers underscored the importance of the Regional Risk Coordination program in their decision to offer reinsurance to the scheme.

The review identified recommendations that, if implemented, might enhance the risk mitigation services and improve the ability to track and measure the performance of those services. The review also identified some service delivery recommendations that would further support

An executive summary of the report was presented to the LGIS Board on 1 July with a supporting presentation by the consultant. The Board tasked WALGA and LGIS Management to report back to the Board with actions for each of the review recommendations.
