6.1 Membership in Development Assessment Panels (DAP)

In Brief

The purpose of increasing the contribution of Local Government Elected Members to a DAP is to match the influence of the contribution of professional members.

DAPs are currently 3 professional planners and 2 Elected Members.

Increasing the contribution of Local Government members can be achieved in a number of ways. For example, the panel could be 3 professional planners and 3 Elected Members with the chair

having a second vote. This model would provide for an equal number of 'voices' to speak from both the professional viewpoint and the community viewpoint.

By increasing the contribution of Local Government members to the DAP process, the profile of Local Government within the broader scope of assessing development applications can be raised.

This increase in the contribution of Local Government to the DAP process may be viewed as the essential 'first step' in a wider range of initiatives that WALGA might investigate to improve the DAP process. For example, WALGA might advocate to bring forward community consultation on an application to a much earlier phase of the process.
