# 5.1 Submission to Statutory Review of the Food Act 2008

That the submission to the Department of Health relating to the Statutory Review of the Food Act 2008 be endorsed.

# 5.2 Local Government Grant Scheme Funding

That WALGA advocates to the Minister for Emergency Services and the Fire and Emergency Services Commissioner for:

- 1. An allocation of Local Government Grant Scheme (LGGS) funding to undertake an audit of existing facilities, appliances, vehicles, and major items of equipment for both Local Government Volunteer Bushfire Brigades (BFB) and State Emergency Services (SES).
- 2. Following the completion of the audit, an allocation of funding through the Local Government Grant Scheme (LGGS) to prepare a Comprehensive Asset Management Plan that:
  - a. Aligns with the principles in the Department of Local Government, Sport and Cultural Industries' (DLGSC) Asset Management National Framework and Guidelines, and the Integrated Planning and Reporting Framework.
  - b. Forecasts the emergency response needs of communities across Western Australia over the next 10 years, to estimate the quantum of the facilities, appliances, vehicles, and major items of equipment that will be needed.
  - c. Outlines a 10 year forward plan of modifications, replacements and additions required.
  - d. Investigates the extent to which future BFB facilities can be co-located with other emergency services facilities.
- 3. The establishment of a Working Group involving WALGA, the Department of Fire and Emergency Services (DFES) and LGIS to oversee the preparation of the Comprehensive Asset Management Plan.
- 4. Support for the Comprehensive Asset Management Plan to be reviewed every five years.
- 5. Support for an increase in Local Government Grant Scheme (LGGS) funding to support the unsuccessful capital grants funding applications by Local Governments to the 2020 21 LGGS Capital Grants Committee.

#### Rationale for alternative Motion

- The alarming decline in rates of walking and riding to school are contributing to the burden of childhood obesity and traffic congestion in WA (as detailed by in the Roadmap).
- Children in the 2020s should expect health outcomes equal to not worse than their predecessors.
   Reversing the childhood obesity epidemic will require advocacy and commitment from all tiers of government.
- A major barrier to children walking and riding to school is the lack of safe routes to school.
- Local Governments have an appetite to install cycle paths. This is evidenced by the rapid completion by Local Governments' of Perth's Long Term Cycle Network Plan in cooperation with the Department of Transport. It is further evidenced by the four-fold oversubscription for cycle path grants by Local Governments.

• The Department of Transport's Roadmap provides a strong argument for increasing grant funding to Local Governments for cycle infrastructure. Recognising this opportunity strengthens WALGAs capacity to get greater funding for much needed cycle infrastructure.

# 6. ZONE BUSINESS

# 6.1 WALGA Urban Forest Working Group Update – Tree Retention on Private Land

#### **BACKGROUND**

Tree canopy makes a substantial contribution to urban amenity and liveability through shade and cooling to reduce urban heat, aesthetics, sense of place, provision of habitat and other ecosystem services. The urban forest includes trees in parks and reserves as well as street trees and trees planted on private land. Whilst many Local Governments have implemented urban forest strategies and extensive community engagement and planting programs to grow canopy in parks and streetscapes, canopy loss continues to occur on private land. Trees on private land across the Perth metropolitan area are under increasing threat of removal during the development process, not only during subdivision for infill development but during redevelopment which frequently results in larger homes and smaller outdoor living spaces.

WALGA established an Urban Forest Working Group (UFWG) in 2019, which is jointly coordinated by WALGA planning and environment teams. The UFWG includes 75 officers from 30 metropolitan and regional Local Governments with diverse experience across planning, sustainability/environment and parks/gardens. Central Metropolitan Zone is represented in the UFWG by: The Town of Cambridge, Town of Claremont, Town of Mosman Park, City of Nedlands, City of Perth and City of Vincent.

WALGA through *the Immediate Priorities for the State Government* document advocates for the establishment of a \$20m Urban Greening grant program. This program would provide funds to Local Governments through a competitive grant program with a focus on planting trees in areas with low canopy cover and increased exposure to heat. It is estimated the program would plant at least 60,000 trees.

# **COMMENT**

In the absence of a state planning policy or other state-wide approach Local Governments are implementing a number of different mechanisms seek to retain trees on public and private land. The City of Nedlands for example is currently progressing an amendment to its local planning scheme and a corresponding local planning policy which would provide for the retention of established mature trees on sites greater than  $1000m^2$ . The City's planning team recently presented its approach and progress to date at a webinar hosted by Greener Spaces Better Places, a nationwide advocacy organisation. The slides from the City's presentation are available as an **attachment** to this agenda. Other common approaches to tree retention by Local Governments are described in the attached briefing note.

In 2021, the UFWG established subcommittees to progress work in three priority areas:

- Tree Purchasing Standards to develop a more robust framework for tree purchasing across the sector to assist with stock quality issues currently experienced by members.
- Masterclass Series Development to increase knowledge within Local Governments of the wholeof-organisation approach towards growing and maintaining healthy canopy.
- Tree Retention to address barriers to protection of existing canopy cover that are within the remit
  of Local Governments to address through the planning system. Officers from Nedlands and Perth
  (Central Metro Zone) are active members of the Tree Retention Subcommittee. Refer to attached
  briefing note for more information on the Tree Retention Subcommittee.

#### Note

#### Discussion at the Meeting

The President from the Shire of Peppermint Grove provided an outline of a range of Local Government policies which aimed to retain or add to the urban tree canopy. The Zone requested that Chris Hossen, Policy Manager, Planning and Building discuss these options with the Shire of Peppermint Grove and present at a future Zone meeting on the range of options to retain or increase tree canopies being undertaken by Local Government.

# 6.2 Campaign to Legislate Second Generation Anti-coagulant Rodenticides (SGARs)

Shire of Peppermint Grove

#### **BACKGROUND**

SGARs are having a devastating effect on owls and other raptors, reptiles, and other animals because of secondary poisoning. SGARS are slow to breakdown. As a result, if a mouse or rat eats the poison and is then consumed, for example by an owl, the owl is consuming a lethal snack and it will die from SGAR poisoning.

There is Australia wide concern about this as evidenced by the article in the December 2021 edition of "Australian Birdlife" published by Birdlife Australia. Attached is a copy of that article. Birdlife Australia has gathered scientific papers about the hazard of SGARs.

The problem is serious because products containing SGARs are freely available in local hardware stores. According to Birdlife Australia the most common SGARs are Brodifacoum, Bromadiolone, Difenacoum, Difethialone, and Flocoumafen but there are others.

#### SECRETARIAT COMMENT

The Association is aware of the increasing concern regarding the effects of anticoagulant rodenticides on birds of prey and other fauna, based on the research cited. This issue is being addressed by the Australian Pesticides and Veterinary Medicines Authority (APVMA) which is drafting regulatory measures to address these types of rodenticides by 2024.

WALGA will investigate options for communicating with Local Government regarding the impacts of these type of poisons and the alternatives.
