#### Comment:

Unfortunately, when it came time to engage 2VNet IT to host the NCZ domain and mail box, they required credit card details and NCZ does not have a credit card. 2VNet IT were not willing to invoice NCZ for the provision of the hosting services.

Another local Geraldton company, Norris & Hyde I.T are willing to invoice NCZ on seven-day terms, with upfront costs totaling \$127.60 (\$55 for the domain name plus \$72.60 for the mail box), which is cheaper than the original hosting option.

The Domain name 'northerncountryzone.com.au' is still available.

A website can be hosted at a later date if required for an annual fee of \$165.

# 10.1 5.1 Local Government Act Review – Sector Positions Following Feedback from Submissions (05-034-01-0001 TB)

#### Recommendation:

That WALGA endorse and submit to the Minister for Local Government and the Department of Local Government, Sport and Cultural Industries:

- 1. The Local Government Act Review Report contained in this agenda; and,
- 2. The attached WALGA Advocacy Positions.

#### In Brief:

- The Local Government Act review process commenced in 2017 with Phase 1 resulting in an Amendment Bill being tabled before Parliament in March 2019
- Phase 2 of the Local Government Act review process will result in a complete review of the Act, the first time this has occurred since the legislation commenced in July 1996
- State-wide forums have been held gaining input on Act review issues
- WALGA has requested Local Governments provide submissions to enable sector positions to be established.
- This item provides information on the submissions received and information gathered through the various forums.
- A Schedule of Local Government Act Advocacy Positions is recommended for endorsement.

# 10.2 5.2 Economic Development Project (05-088-03-0001 ABM DM)

#### Recommendation:

That State Council endorses the:

- 1. Local Government Economic Development: Research Findings and Future Directions Discussion Paper; and,
- 2. Local Government Economic Development Framework.

#### In Brief:

- In 2018, WALGA commenced a project to help Local Governments to understand their role in supporting their local economy, and to provide practical tools to help the sector to understand the types of activities that they can undertake.
- The project outputs will include:
  - i. Local Government Economic Development Framework Tool to assist the sector to understand its role and inform economic development activities.
  - ii. Discussion paper Research summary and policy agenda to support Local Governments to undertake their role in driving local economic development.

- iii. Ongoing support to WALGA members.
- WALGA has engaged broadly with its members and other stakeholders in scoping and progressing the
  project with the assistance of an Industry Reference Group. The project has received positive feedback
  to date both within the sector and from key stakeholders.

# 10.3 5.3 Interim Submission to Salaries and Allowances Tribunal – Elected Member Fees and Allowances (05-034-01-0019 TL)

#### Recommendation:

That the interim submission to the Salaries and Allowances Tribunal relating to Elected Member Fees and Allowances be endorsed.

#### In Brief:

- WALGA has prepared a submission to the Salaries and Allowances Tribunal relating to Fees and Allowances payable to Elected Members to input into the Tribunal's 2019 determination;
- The Submission argues for an increase on the basis of the following four main arguments:
  - 1. <u>Vibrant democracy and good governance</u>: fees and allowances payable to Elected Members should be sufficient to ensure that a diversity of candidates from a range of backgrounds seek election to local Government leadership positions. Further, corporate governance literature suggests that diverse leadership groups make better decisions;
  - 2. <u>Demands of the role</u>: as the complexity of Local Government increases, and the demands placed upon Elected Members grow in the social media age, the remuneration paid to Elected Members for their significant time commitment must compensate them for the personal and opportunity costs of taking on significant community leadership positions;
  - 3. <u>Skills and training</u>: as Elected Members continue to undertake training and with the implementation of the State Government's universal Elected Member training policy likely to occur in the near future the time that Elected Members spend on professional development should be recognised by the fees and allowances framework; and,
  - 4. <u>Economic erosion</u>: in recent years there have been a number of 'no increase' determinations in relation to Elected Member fees and allowances, which means that the relative value of Elected Member fees and allowances have eroded over time. WALGA contends that this trend should be arrested and fees and allowances should be increased.
  - WALGA's submission argues for an increase to the Elected Member fees and allowances payable to Elected Members in the order of three percent, with the Salaries and Allowances Tribunal to consider appropriate economic indicators and increasing training requirements in future years.

# 10.5 5.5 Interim Submission – Draft Position Statement: Container Deposit Scheme Infrastructure (05-036-03-0064 VJ)

#### **Recommendation:**

That the interim submission to the WA Planning Commission on Draft Position Statement: Container Deposit Scheme Infrastructure, be endorsed.

#### In Brief:

 On 21 December 2018, the Western Australian Planning Commission (WAPC) released the draft position statement for Container Deposit Scheme (CDS) Infrastructure for public comment.

- The position statement aims to provide guidance on how container deposit scheme infrastructure could be considered and assessed in the Western Australian planning system.
- The public comment period closed on 19 February 2019, therefore an interim submission was prepared.

# 10.6 5.6 Interim Submission – Parliamentary Inquiry into Short-Stay Accommodation (05-036-03-0016 CH)

#### Recommendation:

That the interim submission to the Economics and Industry Standing Committee's Inquiry into Short-Stay Accommodation be endorsed.

#### In Brief:

- WALGA has previously requested a review of the planning framework in relation to short-stay accommodation.
- WALGA recognises that Local Government is best placed to determine specific controls on short-term rental accommodation.
- Additional guidance is required from the State Government to ensure a robust planning framework exists to support the establishment of local controls, and
- On 13 February 2019 the Association appeared before a hearing of the Committee to provide clarification and elaborate on the interim submission.

# 10.7 5.7 Interim Submission – State Planning Policy 2.4 Basic Raw Materials (05-036-03-0017 CH)

#### **Recommendation:**

That the interim submission to the Western Australian Planning Commission on draft State Planning Policy 2.4 Basic Raw Materials and the Draft Basic Raw Materials Guidelines be endorsed.

#### In Brief:

- On 5 November 2018, the Western Australian Planning Commission (WAPC) released a revised version
  of State Planning Policy 2.4 Basic Raw Materials (SPP2.4) and accompanying guidelines (Guidelines) for
  public comment.
- The revised State Planning Policy aims to provide guidance on planning decisions that will enable responsible extraction of basic raw materials (BRM) used in building and development while ensuring the protection of people and the environment.
- The public comment period closed on 25 January 2019, therefore an interim submission was prepared.
- The interim submission concludes with a recommendation that the Association is not in a position to support the draft SPP2.4 as advertised, due to no exemption being provided to Local Governments undertaking extraction of basic raw materials under Schedule 3.2(3) of the *Local Government Act 1995*.

# 10.8 5.8 Community Policy Reform Project (05-018-02-0010 KD)

#### Recommendation:

That State Council receives the Community Policy Reform Report and endorses the establishment of a Community Technical Reference Group.

#### In Brief:

- WALGA's People and Place: Community Policy team completed a Community Policy Reform Project to gather and analyse community development issues affecting WA Local Governments and establish a framework that will prioritise work for the future.
- Members were engaged via a workshop and online survey with 40% of WALGA members participating in developing the outcomes.
- The Project identified challenges and opportunities for improvement within the Local Government systems and processes, strategies, policies and tools, and determined some high level recommendations to proceed in addressing them.

## 10.9 5.9 Submissions – Draft WA Cultural Infrastructure Strategy (05-012-03-0015 SM)

## **Recommendation:**

That the Submission on the Draft WA Cultural Infrastructure Strategy be endorsed.

#### In Brief:

- Strategic Directions 2016-2031 (SD31) is the first long term strategic direction developed for the arts and culture sector in Western Australia. Pursuant to the aspirations outlined in SD31 Culture and the Arts (WA), a division of the Department of Local Government, Sport and Cultural Industries (DLGSC), has produced the first Draft WA Cultural Infrastructure Strategy (Cultural Infrastructure Strategy).
- The Cultural Infrastructure Strategy has been designed to support the State Government's priorities of job creation and economic diversification, and supporting vibrant, liveable and sustainable communities.
- A series of stakeholder consultations on the Cultural Infrastructure Strategy occurred between June and November 2018.
- WALGA engaged with Local Governments to produce a response to the Cultural Infrastructure Strategy.

# 10.10 5.10 Interim Submission - Public Health Act 2016 Aquatic Facilities and Public Buildings Regulation Review (05-031-01-0001 EDR)

#### **Recommendation:**

That the Interim Submissions provided to the Department of Health *Public Health Act* 2016 Discussion Papers on Regulations for Aquatic Facilities and Public Buildings be endorsed.

#### In Brief:

- The Public Health Act 2016 (the Public Health Act) is progressing through a five-stage process of implementation and is currently at Stage 4.
- All regulations from the previous Health Act 1911 will be repealed and replaced with new regulations at the commencement of Stage 5, which is anticipated to commence in 2021.
- To inform the content of new Aquatic Facilities and Public Buildings Regulations, the Department of Health (DOH) released the Management of Public Health Risks Associated with Aquatic Facilities in Western Australia and Managing Public Health Risks in Public Buildings in Western Australia Discussion Paper (the Discussion Papers) in late 2018. The Discussion Papers were circulated for Local Government consultation for a period of twelve weeks.

• WALGA engaged with Local Governments, including representatives of the Metropolitan Environmental Health Managers Group (MEHMG) to prepare an Interim Submission to each of the Discussion Papers.

## 10.11 5.11 WA Foodborne Illness Reduction Strategy (05-031-01-0001 EDR)

#### **Recommendation:**

That the WA Foodborne Illness Reduction Strategy 2018-2021+ be endorsed.

#### In Brief:

- In May 2018 the Department of Health approached the Association with the request that State Council endorse the WA Foodborne Illness Reduction Strategy 2018-2021+ (the WA Strategy) and Priorities to reduce Salmonellosis (Priorities).
- The WA Strategy and Priorities were developed concurrently to a national Foodborne Illness Reduction Strategy, with the input of WA Local Governments through early consultation in March 2018, and representation on a Strategy Across-Government Advisory Group.
- WALGA assisted the Department of Health in seeking feedback from Local Governments on the WA Strategy and Priorities through our communications channels and contact list. Consultation was open for a period of four weeks in July and resulted in no changes to the WA Strategy and Priorities. The Australian Strategy was developed with input from the Australian Local Government Association (ALGA).
- The WA Strategy involves no additional costs to Local Governments but provides tailored resources to focus attention on the food safety risks that are causing the greatest burden of disease
- The WA Strategy was presented to WALGA State Council in September 2018, at which time an alternative motion was endorsed, which requested more information on roles, responsibilities and costs to Local Governments. This information is located in the comment.

# 10.4 5.4 Review of the Administrative Road Classification Methodology - Regional Roads within Rural/Non Built Up Areas (05-001-03-0033 MM)

#### Recommendation:

That State Council supports the proposed Administrative Road Classification Methodology - Regional Roads within Rural/Non Built Up Areas.

#### In Brief:

- The Administrative Road Classification Methodology is used to guide determination of whether a road is managed by Main Roads WA or Local Governments in accordance with the provisions of the *Main Roads* Act 1930.
- WALGA State Council endorsed the revised Administrative Road Classification Methodology for the metropolitan area in March 2018.
- The development of the revised regional classification methodology was undertaken by Main Roads WA in consultation with WALGA and Main Roads WA's Regional Managers and Regional Asset Managers.

Northern Country Zone Minutes 21 March 2019

- Consultation was undertaken with all Regional Road Groups between September and December 2018 which were largely supportive.
- Regional Roads Groups have been requested by Main Roads WA to submit roads that are Significant Local Government Roads for assessment using the proposed methodology to determine whether they can become State administered roads.

Chapman Valley Shire expressed concern about how Local Government would be consulted on the declassification of roads from State back to Local Government and would like clarification on WALGAs' position on this.

# 11.1 6.1 ERA Business Licensing Inquiry – WALGA Response to Draft Report (05-049-03-0001 DM)

### **Recommendation:**

That State Council note WALGA's response to the ERA's draft report Inquiry into Reform of Business Licensing in WA.

## In Brief:

- The Economic Regulation Authority has released its Inquiry into Reform of Business Licensing in WA draft report. Overall, WALGA is supportive of the recommendations identified by the ERA, to the extent that these will be an important step toward reducing the regulatory burden if implemented by Government.
- While the Association is supportive of the overall direction of the Inquiry's findings, it is concerned that the draft report does not adequately take into account the sector's concerns about fees and charges for licences that have been established under State Government legislation.
- WALGA has written to the ERA requesting that it examines this issue in further detail in the final report.

#### 11.2 6.2 Local Government Performance Monitoring Project 2017/2018 (05-036-04-0004 VJ)

#### **Recommendation:**

That State Council note the results of the Local Government Performance Monitoring Report (2017/2018).

#### In Brief:

- In 2016, WALGA initiated the Local Government Performance Monitoring Project and through this project prepared the *Local Government Performance Monitoring Report* (2016/2017). This report demonstrated the planning and building performance of eleven Local Governments during the 2016/17 financial year.
- Due to the positive reception of the project, WALGA encouraged other Local Governments to participate in the project, which resulted in eight additional Local Governments participating in the 2017/2018 financial year report.
- This new report: Local Government Performance Monitoring Report (2017/2018), demonstrates the planning and building performance of 19 Local Governments in the Greater Perth area.

# 11.3 6.3 Review of Coastal Hazard Risk Management and Adaption Planning (CHRMAP) Guidelines (05-036-03-0065 AR)

#### Recommendation:

That State Council note the Association's input into the review of the Coastal Hazard Risk Management and Adaptation Planning (CHRMAP) Guidelines.

#### In Brief:

- In October 2018, the Department of Planning, Lands and Heritage (DPLH) advised the State's Coastal Management Advisory Group (CMAG) that the DPLH will be completing its review of the CHRMAP Guidelines before December 2018. WALGA is represented on the CMAG.
- WALGA strongly encouraged the DPLH to invite comment from all coastal Local Governments, in accordance with the requirements of the State Partnership Agreement.
- As a result of this advocacy, the comment period for Local Governments was extended from 14 December 2018 to 21 January 2019. WALGA staff aggregated all feedback received and submitted comments to the DPLH on 21 January 2019.
- WALGA staff are confident that the feedback provided, if utilised by the DPLH, will improve the usefulness
  of the Guidelines for Local Governments who are preparing CHRMAPs for the first time and for those who
  are reviewing existing CHRMAPs.

# 11.4 6.4 Completion of the Changing Places and Community Infrastructure Grant Programs (06-072-01-0001 and 06-071-01-0001 Respectively KD)

## **Recommendation:**

That State Council note the completion of the Changing Places and Community Infrastructure Grant Programs.

# In Brief:

- In May 2015, Disability Services Commission approached WALGA to lead the Changing Places program and the Community Infrastructure program. These two Grant Programs had a combined value of \$2.85 million.
- The Grant Programs funded projects that provide community equipment, facilities and spaces which improves access and supports people with disability to join in community life.

- The process was very competitive, with WALGA receiving over \$4.45 million in requests for funding.
- WALGA has now acquitted the Grant Program to the Department of Communities: Disability Services (formerly Disability Services Commission).

#### 11.5 6.5 Update on Building and Energy's State Wide Cladding Audit (05-015-02-0010 VJ)

#### Recommendation:

That State Council note the progress of Building and Energy's State Wide Cladding Audit.

#### In Brief:

- The State Government has initiated a State Wide Cladding Audit (Audit) following the Grenfell Tower disaster in June 2017.
- The Audit involves the Building and Energy division of the Department of Mines, Industry Regulation and Safety (DMIRS) investigating whether buildings are 'low' 'medium' or 'high' risk based on the type of cladding on the building.
- Building and Energy are currently finalising the risk reports and are advising Local Governments of the results of their investigation.
- WALGA and LGIS have prepared a series of documents to assist members in progressing any compliance and enforcement activities upon receipt of the report.

# 11.6 6.6 Report Municipal Waste Advisory Council (MWAC) (01-006-03-0008 RNB)

#### In Brief:

#### 11.7 6.7 Electric Scooter Shared Services (05-005-03-0010MM)

#### Recommendation:

That State Council note the discussion paper on Electric Scooter Shared Services.

#### In Brief:

- Electric scooters, known as e-scooters, are powered by a rechargeable battery and have a maximum speed of approximately 25km/hour.
- In the past two years e-scooter shared services have rapidly expanded across the world offering increased transport mobility choice and convenience.
- Any operation of an e-scooter shared service in WA will, in the first instance, require consideration by the State Government to provide an exemption or amend the Road Traffic Code 2000, to legally allow the operation of e-scooters to travel over 10km/h.

- Should the State Government provide exemptions or amend the legislation, an operator will require permission from the relevant Local Government to operate an e-scooter shared service through applying for a permit pursuant to relevant local laws.
- A Local Government will need to set out terms and conditions in support of issuing a permit to an operator.
  The terms and conditions establishes the principles, practices and obligations that an operator of an escooter shared service is required to comply with as a condition of a permit to mitigate public amenity and safety risks.

# 11.8 6.8 Systemic Sustainability Study Actions Update (05-034-02-0003 TB)

#### Recommendation:

That State Council note the update relating to the Actions from the Systemic Sustainability Study Report.

#### In Brief:

- The Systemic Sustainability Study (SSS) was a key research and consultation process undertaken by WALGA during the second half of last decade;
- The SSS culminated in a final report containing 39 Actions aimed at addressing Local Government sustainability issues associated with revenue, financial management, capacity and expertise, service delivery and leadership;
- In the context of the Review of the Local Government Act, State Council requested the secretariat to report on the status of Actions from the SSS report;
- Of the 39 Actions, 19.5 have been completed through WALGA undertakings or advocacy successes;
- Of the remaining half, 7 were referred to the State Government and 12.5 require ongoing advocacy, particularly through the Local Government Act Review process;
- A full table of the Actions and their status is included in the 'Comment' section of this agenda item.

# 11.9 6.9 2018 WALGA Annual General Meeting Action updates (01-003-02-0003 TB)

# 12.1 Regional Tourism

## **Recommendation:**

That the Northern Country Zone of WALGA establishes a Regional Tourism Working Group to map a way forward for regional tourism initiatives in the Mid West and to work with the Mid West Development Commission to develop a 'Mid West Pathways' project.

# **Background:**

At the 27 August 2018 meeting, members discussed the need for a zone-wide approach to tourism. It was agreed that the February 2019 meeting have a strong focus on this issue and that the Executive Officer work with WALGA to assist with the process to bring all the players together and commence the formulation of a regional tourism strategy.

#### **Comments:**

Prior to contacting WALGA, the Executive Officer did some research into some of the regional tourism initiatives currently available in the Mid West region. This is summarised below:

#### Mid West Tourism Development Strategy

Link to Strategy - http://www.mwdc.wa.gov.au/f.ashx/Mid-West-Tourism-Development-Strategy.pdf

The Mid West Development Commission, in conjunction with Regional Development Australia, the Department of Planning and the Mid West Tourism Alliance, developed the Mid West Tourism Development Strategy (Strategy) during January to June 2014. All local governments were visited during the consultation period and regional workshops were held at Meekatharra, Mingenew and Geraldton. A desktop review was undertaken of 40 strategies and plans across the Mid West, including the local governments' and citys' corporate plans.

The Strategy aims to facilitate a coordinated, collaborative approach to grow regional tourism and maximise the Mid West's existing tourism capacity.

The Strategy addresses fundamental gaps and opportunities in Mid West tourism while recognising differences in the tourism life-cycles of three sub-regions – Batavia Coast, Murchison and North Midlands. The Batavia Coast sub-region is made up of the City of Greater Geraldton and the Shires of Irwin, Northampton and Chapman Valley. The North Midlands sub-region is made up of the balance of the NCZ members – the Shires of Coorow, Carnamah, Mingenew, Morawa, Perenjori and Three Springs. The Murchison sub-region is made up of the Shires of Cue, Meekatharra, Mount Magnet, Murchison, Sandstone, Wiluna and Yalgoo.

The Strategy lists the strategic aims for regional tourism development as:

- 1. Increase accommodation capacity from camping through to resorts;
- 2. Open up sites and places previously overlooked or under-developed to enhance the Mid West's appeal as a destination:

- 3. Improve the quality and distribution of information for pre-trip planning and way finding;
- 4. Attract more high-yield visitors and the growing self-drive and RV market;
- 5. Increase the range of eco nature-based activities, attractions and experiences.

50+ development options were assessed against gaps/opportunities/trends/competition. 10-12 were shortlisted for each sub-region at the sub-regional workshops and then further assessment identified the top 6 priorities for the Mid West and the top 5 priorities for each of the sub-regions, as listed below.

# Mid West regional priorities:

- 1. Develop and open up Abrolhos Islands
- 2. Develop Kalbarri National Park and Skywalk
- 3. Develop Coastal Nodes
- 4. Develop Zuytdorp Coast 4WD trail
- 5. DPAW Conservation Estate
- 6. Geo Tourism and Geo Park

NB: Some of the Mid West regional priorities will be important to some but not all members.

# Batavia Coast sub-region priorities:

- 1. Kalbarri to Shark Bay 4WD trail;
- 2. Kalbarri NP iconic skywalk, road sealing, naturebank eco camp, campground, enhanced trails;
- 3. Coastal campsites and visitor nodes from Greenhead to Kalbarri;
- 4. Eco accommodation and amenities on Abrolhos Islands;
- 5. Headworks and pre-approvals for a co-located Geraldton conference function centre.

#### North Midlands sub-region priorities:

- 1. Extend and enhance the Wildflower Way;
- 2. Develop interactive components of the Artbelt Project, creating a drive 'loop' with year-round appeal;
- 3. Develop half/full day self-drive routes with rest and overnight areas;
- 4. Upgrade a selection of trails to multi use (walk, bike, horse, 4WD) and/or create new trails at popular sites; and
- 5. Audit potential campsites and develop 4-5 eco campgrounds.

# Murchison sub-region priorities:

- 1. Develop tourism infrastructure on DPaW's conservation blocks (e.g. Muggon Block six properties, Doolgunna Mooloogool Block two properties and Dalgaranga Block four properties);
- 2. Develop a geo park across the subregion;
- 3. Develop prospecting reserves for visitors;
- 4. Support pastoral properties to develop tourism infrastructure; and
- 5. Develop lookouts and safe viewing sites for flash rain events

# Sub-regional Action Plans focusing on:

- 1. Marketing, Branding and Promotion
- 2. Capacity Building; and
- 3. Improved standards and service delivery

were developed and imbedded into the Strategy (Batavia Coast sub-region pages 58-60; North Midlands pages 69-71; and Murchison pages 63-65).

As well as highlighting regional and sub-regional priorities, the Strategy drills down even further and highlights local initiatives that each Shire in the sub-regions can monitor and/or develop into new infrastructure/activities/experiences.

The strategy recognises that Australia's Coral Coast and Australia's Golden Outback are the collaborative marketing organisations for the Mid West, under the umbrella of Tourism WA. They are tasked with marketing and branding for the region, aligned closely to the State's tourism goals.

# Australis's Coral Coast

Australia's Coral Coast undertakes an annual program of strategic marketing activities. These activities are designed to attract visitors to the region and to increase the region's international and domestic profile.

One of those activities is the publishing of an annual Holiday Planner and all members except Morawa and Perenjori have advertised in Australia's Coral Coast Holiday Planner 2019. Morawa and Perenjori have advertised in the Australia's Golden Outback Holiday Planner 2019.

Road trip itineraries are included at the back of the planners, including two wildflower trip itineraries:

'The Weekend Wildflowers' trip goes from Perth to Eneabba and back down the coast through Green Head.

'Fields of Everlastings' trip goes from Perth through Coorow, Carnamah, Three Srings, Mingenew, Mullewa, Nabawa (Chapman Valley), Northampton, Kalbarri, Geraldton, with side-trips to Pindar and Dongara.

Australia's Coral Coast Holiday Planner 2019 is available at Tourist Bureaus across the State and available for download from the Australia's Coral Coast website.

#### Australia's Golden Outback

Australia's Golden Outback is the recognised marketing organisation (for the outback) under the umbrella of Tourism Western Australia and has the specific task of marketing and undertaking promotional activities that

will establish the region as a highly desirable tourism destination for intrastate, interstate and international visitors. Its mission is to increase visitor numbers to the region, extend the average length of stay and encourage visitor spending.

The Golden Outback is divided into four regions, with Morawa and Perenjori being included in the Wheatbelt Region. They feature in the 'Everlastings Trail' and the '3 Day Wildflower Country' trip (Midlands route).

Australia's Golden Outback Holiday Planner 2019 is available at Tourist Bureaus across the State and available for download from the Australia's Golden Outback website.

#### Gascoyne Murchison Outback Pathways

Back in 2004, the Gascoyne Murchison Outback Pathways project, initiated by the Gascoyne and Midwest Development Commissions, was officially opened. Eleven local governments - Carnarvon, Cue, Exmouth, the City of Geraldton, Meekatharra, Mt. Magnet, Mullewa, Murchison, Sandstone, Upper Gascoyne and Yalgoo participated in the project.

This is a great example of a cross regional initiative that still provides economic benefits to the regions to this day.

#### Summary:

- the Mid West region has a tourism development strategy the Mid West Tourism Development Strategy;
- Regional advertising is currently supported by Australia's Coral Coast and Australia's Golden Outback;
- The Northern Country Zone member councils do not currently collaborate in the sphere of tourism promotion and may like to consider a project similar to the Gascoyne Murchison Outback Pathways project.

There are currently more questions than answers.

- 1. Does the group feel that the Mid West Tourism Development Strategy addresses their needs as far as regional tourism goes ie is it a document that is relevant five years on?
- 2. If not, is it time to request a review of the Strategy rather than to embark on the development of a new one?
- 3. If members are looking to develop a new strategy, how much money are they willing to commit to its development?
- 4. If the Strategy is still relevant, are the members willing to start working through the Action Plans, including establishing a regional tourism website (with links to it from individual council websites); developing regional branding; and establishing pooled funding?
- 5. Does the group feel that the Gascoyne Murchison Outback Pathways project sets a suitable standard for a Mid West regional tourism project (whatever that may be called)?
- 6. If so, would the members consider including the Murchison Shires in such a project?

Mr Gavin Treasure was invited to update the meeting on the status of the various regional and sub-regional priorities within the Mid West Tourism Development Strategy:

Kalbarri Skywalk – supporting infrastructure has been completed; Skywalk construction contract has been awarded with completion expected late 2019;

Abrolhos Islands – set to become one of WA's newest National Parks; funding of \$10 m has been granted by the state over 2 financial years to upgrade the jetty and to provide airstrip and camping facilities;

Coastal Nodes – the coastal Shires have completed many coastal nodes, from Sandy Cape in the South through to Lucky Bay in the north. Developing these camping sites along the coast will encourage tourists to stay in the region for more than one night;

Kalbarri to Shark Bay 4wd track – need agreement between two shires for unsealed road along the Zuytdorp Cliffs; similar to Bibbulmun track. Terms of Reference have been drafted;

DPaW Conservation Parks – sites were bought for a reason and earmarked for conservation parks. Karara block has been used as a test site and is currently being developed;

Geo tourism – Geoparks are recognised by UNESCO as an area of important geology which encourages conservation, community growth and economic development; there are Geo parks all over the world, but none in Australia; the Murchison region has the oldest rocks in the world; oldest working mine (Wilgie Mia) in the world; many other key locations; the seven Murchison Shires are working towards establishing a geopark in their region; it's about marketing – putting the natural sites on the map.

The MWDC Board are very keen to maintain tourism with new projects being considered at the moment, such as Geraldton Museum; astro tourism; Mid West Tourism Drive. The Board are project focussed, so that if funding becomes available, the projects are ready to go.

There was no support from members to establish a working group to look at regional tourism initiatives. The general consensus was that a working group would replicate work already being done by groups within the region and that it would be preferable for the zone meeting to provide opportunity for individual councils to bring their projects to the table. Mr Treasure is happy to work with the zone on this matter.

As there was no mover for the Recommendation, it lapsed.

# 12.2 Invitation to Join Rural Water Council of WA Inc

#### Recommendation:

That the Northern Country Zone of WALGA join Rural Water Council of WA Inc and appoint two voting delegates.

## **Background:**

A letter from the Rural Water Council of WA Inc (RWC) was received by our Chair on 5 October 2018 and forwarded to the EO on 8 October 2018 for inclusion in the next in-person meeting agenda. The invitation summarises the aims and objectives of RWC, notes that it meets three times each year in March, July and October, lists the current members, notes the 2018 membership fee as \$100 per member and notes that each member is entitled to two voting delegates.

#### **Comments:**

In order to get a better understanding of what benefits RWC can offer NCZ members, I phoned Executive Officer Robert Dew on 7 March 2019.

The core membership of RWC to date has been the Eastern Wheatbelt Shires, but the issues dealt with and lobbied for are relevant across all dryland agricultural areas, including the Northern Country Zone council/city areas. These issues include but are not limited to the availability and cost of water for agricultural use; ground water licensing; local government-controlled sewerage plants including effluent disposal; issues around cost and quality of town water supplies; access to standpipes including use of swipe cards; community water supply scheme; desalination; farmlands smart meter project; water harvesting projects.

Representatives from the Water Corporation and Department of Environment Regulation regularly attend and report at meetings, as do relevant Members of Parliament.

When asked why NCZ should join, Robert responded that the greater the member numbers, then the louder the voice when lobbying to government on issues relevant to members. Not all issues dealt with are relevant to all members all the time, but members unite behind each other to ensure a better outcome on individual council or regional issues.

According to the NCZ Constitution, two of the Objects of NCZ are to provide a united voice for local governments in the Northern Country Zone and to work collectively to enhance the sustainable social, environmental and economic development of the Northern Country Zone at strategic and project levels.

Sound management of our water resources and infrastructure is imperative to ensure the survival of rural towns and farming communities. Any work undertaken on a collaborative regional level to ensure the

sustainability of a quality and affordable water supply would certainly fall within the above-mentioned Objects of the NCZ.

The Shire of Three Springs attended the Rural Water Council of WA Inc meeting during the week as they had decided to join as an individual council.

#### **Background:**

At the NCZ November 2018 meeting, it was agreed to adopt the NCZ Draft Submission on the WA Country Health Services' New Strategy to Strengthen WA's Country Ambulance Services and to submit it to WA Country Health Service via the online portal.

The Submission was uploaded by the EO on the 27<sup>th</sup> November 2018.

#### **Comments:**

According to the WA Health website as viewed on 7 March 2019:

The final Strategy is expected to be released in coming months, with implementation commencing. It is recognised there is a lot of work to do in progressing the recommendations, so this will occur in stages.

Provision of feedback is now closed.

Over the consultation period, WA Country Health Service received 27 submissions and 937 people provided feedback through a structured survey.

The feedback received during public consultation is now being reviewed and incorporated into, the final Strategy. This will then be submitted to the Minister for Health. Work on policy development is already underway.

A plan is being developed to guide the next stages to meet and action the recommendations.

Mr Ross McKim noted that the City of Greater Geraldton sits on the Municipal Waste Advisory Council and that the 3-bin system is only being introduced to urban areas initially – the regions will be dealt with separately. The City is also concerned that the Waste Levy is only a levy if it is used on waste, if not, it's a tax. There is pressure from community members to introduce recycling to the City – a study is underway on a trial to recycle next year.
