#### Late Item 5.7 Urban Forest Grants Program

By Town of Victoria Park

#### **BACKGROUND**

In March 2019, the Town of Victoria Park Council at its Ordinary Council meeting, adopted its advocacy priorities for 2019. One of the four advocacy priorities is advocating for Urban Forest Strategy initiatives. This was following Council's endorsement of the Urban Forest Strategy at its Ordinary Council meeting in September 2018, which aims to increase the Town's tree canopy to 20 per cent, and will require the planting of up to 256,000 trees. An Implementation Action Plan to deliver the Town's Urban Forest Strategy, is currently being drafted.

The Town of Victoria Park's Advocacy Priorities 2019 document outlines that the Town advocates for dedicated funding grants to help local governments deliver their Urban Forest Strategies. Stakeholders to help achieve this advocacy priority are identified, with WALGA recognised for seeking their support in the establishing a Local Government Greener Perth grant program, funded by the State Government.

#### COMMENT

The Town of Victoria Park's Urban Forest Strategy aims to increase the Town's tree canopy from 10 to 20 per cent, which will require the planting of up to 256,000 trees. This ambitious tree canopy target will require dedicated resources and significant financial investment to achieve.

The Town of Victoria Park's Advocacy Priorities 2019 document outlines that the Town advocates for dedicated funding grants to help local governments deliver their Urban Forest Strategies. To achieve this, it is recommended that the State Government establishes a Local Government Greener Perth grant program, similar to what is currently provided by the NSW State Government.

In NSW, the Five Million Trees for Greater Sydney Grant from the NSW State Government supports local councils in Greater Sydney to enhance urban tree canopy by co-funding tree planting projects in public spaces such as streets, parks and plazas.

The Town of Victoria Park's Advocacy Priorities 2019 document seeks for the State government to provide \$10 - \$20 million annually for local governments to access via a grant program to increase tree canopy.

In 2016, the canopy cover of the Greater Perth region was 19.95%, as documented in the "Better Urban Forest Planning" guiding document (November 2018) published by the Western Australian Planning Commission (WAPC) in conjunction with the Western Australian Local Government Association (WALGA). This was a decline of 2.32% canopy cover from the previous survey in 2009.

#### **SECRETARIAT COMMENT**

The recent release of the *Better Urban Forest Planning Guide* by WALGA and the Department of Planning, Lands and Heritage highlighted the current deficiency of tools currently available to Local Government to adequately deliver on the goals and objectives of their Urban Forest Plans, and also to facilitate positive outcomes through the planning system for urban forests.

In light of these deficiencies the Planning and Environment teams at WALGA have convened an Urban Forest Working Group that will bring together Local Government officers and have a scope to investigate all matters relating to Local Government's role in Urban Forest management planning and implementation.

The purpose of the Local Government Urban Forest Working Group is to build the capacity of Local Government, share information, identify gaps and develop practical planning outcomes and tools. The Working Group will operate as a community of practice for members to share their experiences, take collective action and responsibility for progressing agreed priority issues. At time of writing the Group has membership from 18 Local Governments and is scheduled to meet in late July for its inaugural meeting. The Vision and priorities of the Group will be set by the Group itself.

WALGA is also advocating for urban forests to be a priority in the State Climate Change Policy currently under development by the WA Government.
