1. DECLARATION OF INTEREST

2. DEPUTATIONS

Chair, Mayor Peter Long brought forward the Deputation prior to the commencement of the Zone meeting.

2.1 Emergency Preparedness - nbn

Naomi Evans, Head of Regional Community Affairs (WA), nbn Local, provided a presentation on Emergency Preparedness.

The nbn has a range of mobile and critically located satellite communication devices that transmit a local wifi signal and enable mobile phone usage when fixed line and mobile services are down. There has been substantial investment in these to help during disasters like Kalbarri's loss of power and comms after TC Seroja. Nbn supplied satellite and broadcast local wi-fi services (known as STAND) have now been provided to emergency evacuation centres in the Pilbara.

The nbn has high-speed wireless serviced business zones in Port Hedland and other locations. It has also developed a Digital Planning Framework for the region.

2.2 Pilbara Strategy Planning Session

Zone members took the opportunity to discuss priority topics for their communities and to look at strategies to address similar issues.

Topics raised and discussed were:

• Digital Connectivity Plan

Following the presentation by NBN, THE Zone considered that it should look to prepare a regional Digital Connectivity Plan.

• Economic Development issues

Housing

Issues raised:

- the lack of investment by the State in providing both social and service worker (ie low paid) accommodation
- problems with land availability in some of the inland towns
- push-back by the resources companies on land release in the inland towns
- closing of Aboriginal communities and resultant town residence overcrowding
- the State renting off the open market and refusing to build new State-owned properties
- State-owned unliveable housing etc.

The possibility of councils joining together to make their own housing authority, much as has been discussed at RCAWA, was considered. The idea is that a number of councils joining together can combine their resources and use these to leverage substantial third party moneys from government and private sources. With the very substantial funds obtained, large builders could be contracted to construct many houses in each jurisdiction: it is recognised that it is far cheaper per unit when many houses are built by the same company. This was considered and thought worthy of further investigation.

- A) Action Stephen Harding, CEO East Pilbara to coordinate a meeting between Pilbara Local Government CEO's, RDA and PDC to put together a scope of work to progress a housing strategy for the region.
- B) Action: Tony Simpson, RDA Pilbara to organise a meeting between Zone Local Government representatives and Northern Australia Infrastructure Fund representatives. Also, the potential to invite David O'Loughlin (former ALGA President) who is on the "National Housing Supply and Affordability Council" to speak to the zone.

Justice System

Across the Pilbara, we know too well the child safety issues caused by parental alcohol and drug consumption leading to poor parenting, physical, mental and sexual abuse, street children and the policing and justice issues that result. We also see locally, how much of the money poured into these issues by the State is not effective – the collapse of the Roebourne 6718 Advantage Plan being one example. Children of 10-15 years roaming the streets at night and breaking into property are a major concern but are either let off with no charge or are sent to Perth for detention – both are unsuitable responses to an endemic problem.

The issues of insufficient and inadequate housing, overcrowding and child safety are linked and the meeting decided to task the PCZ Housing working party to gather information and propose a way forward.

Transport Corridor

Transport within and across the Pilbara is a major limitation on economic development and liveability across the region. Issues identified include:

- A lack of direct routes across the region
- Insufficient maintenance of roads (and bridges) which are subject to ever-increasing traffic numbers and axle loads as new mines are opened up.
- Insufficient system resilience: quite small rain events cut off roads and at times destroy bridges
- Transport in and out of the region would be improved by a shipping service to Perth

Child Safeguarding

- 1. Local Government supports:
 - a. the recommendations from the Royal Commission into Institutional Reponses to Child Sexual Abuse 2017, in particular Recommendation 6.12 which can be achieved by Local Government implementing and embedding child safeguarding across its functions with support from Governments at the national, state and territory levels; and
 - b. the ten National Principles for Child Safe Organisations (Australian Humans Rights Commission).
- 2. The State Government through an Independent Oversight Body should provide financial, resourcing and capacity building support to Local Governments to implement and embed child safeguarding across its functions, through the provision of:
 - a. supporting materials such as template policies, procedures and guidelines;
 - b. consistent key messaging and resources to promote and share in venues and facilities and online;
 - c. examples of best practice, including case studies;
 - d. self-assessment tools to assist Local Government;
 - e. ongoing training and skills development for Local Government staff, including online training options:
 - f. funding for the delivery of the child safeguarding function within smaller, less well resourced (Band 3 and Band 4) Local Governments; and
 - g. expert officers within each region to provide support and guidance to Local Government on child safeguarding.

3. The Local Government sector supports Local Government participation in the State's National Redress Scheme, with full financial coverage by the State.
