#### 6.1 Department of Planning, Lands and Heritage – Request to Present

#### **BACKGROUND**

WALGA has been supporting the Department of Planning, Lands and Heritage in the final stages of consultation that will support the implementation of the Heritage Act 2018. This process will take submissions on an initial set of regulations to accompany the Act: develop guidelines for local heritage surveys; and seek expressions of interest for a new Heritage Council, which will be appointed once the new Act is proclaimed. Local government input to the consultation process is strongly encouraged, with submissions taken until mid-April. Further information can be found www.stateheritage.wa.gov.au.

Following the consultation process, the Department has offered to give a short presentation to each Zone noting highlights of the new Act of relevance to Local Government, and identifying further opportunities for training and information.

#### 6.2 Governance Review of WALGA

#### **BACKGROUND**

In accordance with clause 5.3(3) of the City of Bayswater *Standing Orders Local Law 2018*, the Chief Executive Officer may provide relevant and material facts and circumstances pertaining to the notice of motion on such matters as policy, budget and law.

WALGA is the peak industry working body for Local Government in Western Australia. WALGA represents 138 local governments in Western Australia with the City of Nedlands being the only Local Government who are not a member.

Zones are groups of geographically aligned Member Councils who are responsible for direct elections of State Councillors, providing input into policy formulation and providing advice on various matters.

The WALGA State Council is the key decision body on behalf of all member Councils and is responsible for sector-wide policy making and strategic planning on behalf of Local Government in Western Australia. Under Clause 9(1) of the WALGA Constitution, the State Council is made up of 24 members, being 12 from country constituencies and 12 from metropolitan constituencies.

A review of WALGA's governance model would provide an opportunity for both WALGA and WALGA members to consider whether the current Zone and State Council representation systems accurately reflects the current Local Government sector and whether improvements could be made.

## 6.3 Local Government Act Review Reference Group - UPDATED

#### Motion:

The East Metropolitan Zone endorses the following recommendation to WALGA State Council:

That WALGA requests the Minister appoint:

- i) two Elected Members of Local Government from metro districts; and
- ii) two members of the public who are not members of any government-appointed committee or community lobby group

to become members of the Local Government Act Review Reference Group, and

iii) when the Reference Group's process is finalised and legislation is drafted, that the draft legislation be referred to a Parliamentary Committee to allow public hearings and input into the proposed legislation.

#### Reasons:

The composition of the current Reference Group for the reform of the Local Government Act includes four representatives from each of LG Pro, WALGA, DLGSCI, members of other state government departments and seven lobby/industry groups.

It includes only two Elected Members of Local Government and both are from country districts and are office holders within WALGA. It includes no members of the general public.

The broadening of the Reference Group to include two members of the public, who are not associated with any government-appointed committee or community lobbying body, demonstrates a commitment to increasing community interest and engagement in Local Government. Increasing community engagement is a major goal of the reform process.

The Reference Group of 23 currently includes only 2 Elected Members of Local Government. In contrast, there are 4 representatives from Local Government Professionals.

Increasing the Reference Group to include 4 Elected Members will better support the Reference Group's deliberations to enhance the capacity of Councillors to do their job. This enhanced capacity requires adequate and appropriate supports to be contained within the new legislation.

Four Elected Members may deliver a richer outcome in terms of deliberation about the public submissions for reform of the Act.

A balance of Elected Members from country and metro districts is a significant principle within WALGA and provides a balanced input of differences in geographic outlook.

A Parliamentary Committee brings a set of views and a process with no vested interest. This stage of the process provides for final public comment on the draft legislation. This is an appropriate way to build community interest and participation in local government.

#### Summary

#### **SECRETARIAT COMMENT**

The Minister for Local Government has formed a reference group and appointed the representatives that will be considering the submissions on the Act review matters going forward. The Group has no powers and is a further consultation group for the Minister in addition to the current process.

In respect to WALGA's representation, WALGA has two (2) Elected Members, of which one is the WALGA President and the other is the Chairperson of the Governance Policy Team, plus two (2) senior staff (for technical expertise) on the group. In addition WALGA's Elected Members are supported by a further five (5) Elected Members from the Governance Policy Team (Metropolitan and Country representation) that also provide input via the WALGA delegates.

WALGA's Elected Member representatives are appointed by their Local Governments to represent them at WALGA Zone meetings, and are then elected by their Zone to form WALGA's State Council. As a consequence, WALGA's representatives put forward information based on our consultation with all Elected Members.

The 2 officers from WALGA have extensive experience in Local Government in both metropolitan and regional Local Governments and advocate on sector views on issues following consultation processes.

As at 6 March 2019, the Department of Local Government has received 1590 submissions. 45% of submissions are from the community, 31% from Local Government staff and 15% from Elected Members, the remaining 8% is from various organisations including Councils. WALGA President, Cr Lynne Craigie recently emailed all Elected Members encouraging submissions prior to the deadline and to encourage Councils to put forward their submissions.

WALGA has been regularly communicating with the sector on the Act review. WALGA and the Department collaborated to facilitate 19 forums across the State in October/November 2018 and also held a Future of Local Government Forum on 30 January 2019 where 230 Local Government representatives attended.

Following this current consultation process, The Department of Local Government in-conjunction with the State Solicitors office will prepare a new draft Local Government Act. The draft (Green Bill) will come back to the sector for consultation as per the State/Local Government Partnership Agreement. Consultation on the draft bill would be expected in 2020.
