  - f. funding for the delivery of the child safeguarding function within smaller, less well resourced (Band 3 and Band 4) Local Governments; and
  - g. expert officers within each region to provide support and guidance to Local Government on child safeguarding.
- 3. The Local Government sector supports Local Government participation in the State's National Redress Scheme, with full financial coverage by the State.

## 7. BUSINESS

# 7.1 Advocacy on Environmental Issues

By City of Canning

#### **BACKGROUND**

The City is currently proposing to undertake a trial translocation of Western Grey Kangaroos (Kangaroos) that are located on and around its Canning Vale Waste Transfer Site. The City has been working with a number of relevant stakeholders; however, it has been identified that one of the significant issues for this translocation project (and other potential translocations in the metropolitan area), is the difficulty identifying sites to rehome the Kangaroos.

The Department of Biodiversity, Conservation and Attractions has indicated that most of the potential Crown reserves are already at capacity and unable to take on Kangaroos in large numbers. Further, the

sites with capacity cannot take the populations of the scale that exist at the Canning Vale site (estimated 250+), or similar sites across Perth that are subject to a form of disturbance through development.

Kangaroos are a matriarchal society, and it is important that mobs are not separated. It is therefore preferable to identify rehoming sites that have capacity for significant numbers of Kangaroos. Mobs are usually made up of 12-20 Kangaroos including one male, several females and their young either in pouch or at foot.

The Department has identified government land holdings for the trial, but have suggested identifying private landholdings that have capacity for the remaining kangaroos; however, it is currently up to the individual entities like the City of Canning to find those potential landholdings.

Given the stakeholders involved and corporate knowledge within WALGA, additionally within member Local Governments in and around Perth, we are hopeful that through their networks, WALGA will be able to help seek out potential landowners who would be happy to help rehome displaced Kangaroos. This is likely an issue for many metropolitan local governments.

## Dealing with environmental issues where there are multiple Government landowners

There is currently a responsibility gap with respect to the consideration of environmental impacts in areas where there are multiple government landowners. When developments occur, especially in greenfield sites in the metropolitan area, there needs to be a strategic assessment of the environmental impact where migratory fauna cross multiple sites owned by different entities.

Whilst a development may be confined to a single site, its environmental impact may spread across multiple sites and it's therefore important to be able to assess and manage those impacts appropriately.

An example can be found in Canning Vale, where successive projects by different entities have affected local fauna including Western Grey Kangaroo populations, which travel across different sites.

As part of its planning for the proposed Jandakot Eastern Link Road and Canning Vale Regional Sporting Complex, the City of Canning has been investigating some of the relevant environmental impacts, including to both the flora and fauna that may be affected. The impacts to the fauna were brought to a head by the construction of the Metronet Thornlie-Cockburn Link, which impacted local Western Grey Kangaroo populations.

In response, the City of Canning commissioned a Kangaroo Management Plan, which was based solely on managing Kangaroos on its own land. This is despite the fact that the Kangaroos belong to a larger site and migrate between several parcels of land in the area including the City's Land, the City of Melville's Ken Hurst Park, City of Cockburn land and land owned by Jandakot Airport Holdings. There is also crown land in the area owned by the WA Planning Commission, as well as land being developed by Metronet.

The reality is the fauna footprint crosses jurisdictions and whilst each stakeholder is focused on its own respective area, these projects/developments may have an impact on fauna across a larger area.

When it commissioned its Kangaroo Management Plan, the City sought support from adjacent landowners, which was apparently declined, leading the City to conduct its plan in isolation. In effect, the Kangaroo Management Plan considered the entire kangaroo population, but only one portion of the land available (that is, the City of Canning's), and inevitably concluded that there is not enough land for the current population despite not considering the adjacent landholdings that the Kangaroos frequent. This process may not result in good environmental outcomes because not all the information was considered.

The Kangaroos are just one species impacted – There are 65 known fauna species that frequent the City of Canning land and 56 fauna species that have been identified on the City of Melville's land, as well as 188 flora species. These figures include some endangered species including Bandicoots, Carnaby's Black Cockatoos and Forest Red Tailed Black Cockatoos.

In recognising that the fauna impacts are not confined to one landowner or one local government jurisdiction, there needs to be a planning instrument developed by the State Government that ensures environmental issues are considered holistically across jurisdictional lines where appropriate.

There also needs to be a responsibility placed on all parties to be engaged in the process, and not leave responsibility to one entity.

The indefinitely suspended Green Growth Plan had at its core the right principal with respect to having a strategic holistic plan for future development whilst assessing areas of environmental significance. This has been indefinitely on hold since 2017.

In this context, it has long been identified that a rail line connection would be built in the Canning Vale precinct, the Jandakot Eastern Link Road has been proposed for a number of years, the Jandakot Airport Holdings development footprint has had many expansion stages, a regional sports precinct has been on the radar for many years – yet the environmental consequences haven't been properly considered or planned for.

Regrettably these types of developments often have time pressures as the appropriate environmental assessment occurs around the same time that funding is being sought/secured and the development is imminent.

The State Government needs to take a lead role by implementing a planning instrument to ensure the environmental consequences and any required management are strategically assessed, and all relevant stakeholders/landowners are required to be involved to help mitigate the risk of negative outcomes for the flora and fauna, including some who are endangered, that call the area home.

This issue is not confined to the Canning Vale/Jandakot example, and is an issue across the metropolitan area. We have been led to believe that the issues are quite prevalent where Metronet lines are being built, with a number of local governments dealing with these similar issues.

The State Government needs to take the lead, and we believe WALGA is well placed to advocate for a solution.

#### SECRETARIAT COMMENT

Translocation of kangaroos is complex and has limited conservation rationale. Translocation is possible, but is technically demanding, labour-intensive and expensive. For these reasons is generally only applied to threatened species programmes.

Analysis of recent kangaroo translocation efforts across Australia indicate a low survival rate, with poor animal welfare outcomes for translocated animals. Translocations lead to high rates of both injury and death during capture and transport. High rates of death are also found in the months following translocation, and kangaroos are highly susceptible to capture myopathy.

Consideration of these factors is essential to appropriately weight the benefits of translocation over other management options for isolated kangaroo populations.

The role for communicating these challenges and working with landowners on appropriate options is the responsibility of the Department of Biodiversity, Conservation and Attractions (DBCA). Further, any regulatory change to manage the issue of animal herding from one piece of land to another during development would be a matter for DBCA.

Considering the complex issues and risks associated with macropod translocation and the clear role for the State Government in communicating and regulating this issue, it is not seen as appropriate for WALGA to lead a consultation piece as proposed in the zone recommendation.

In December 2022, the State Government announced the discontinuation of the Strategic Assessment of the Perth and Peel Regions (SAPPR) and will in its place prioritise regional planning for Perth and Peel

under WA's Native Vegetation Policy, which will address cumulative environmental impacts in Perth and Peel. No further detail on this new approach has been provided.

Kangaroos, not being listed threatened species, were not specifically considered as part of the SAPPR.

However, the strategic approach would have provided greater certainty by determining the areas to be protected from development and areas where development can occur, the type of development that will be allowed and the conditions under which development may proceed. It would also have assisted in the identification of suitable off-set land outside the Perth and Peel regions.

WALGA will continue to engage with DBCA on the issue of kangaroo management and the Department of Water and Environmental Regulation (DWER) on the implementation of WA's Native Vegetation Policy and bring the suggestions and concerns of the City of Canning to the Departments' attention as part of these discussions.

#### **Voice to Parliament**

State Council resolved to consider three Zone items from the November 2022 round of Zone meetings relating to the Aboriginal and Torres Strait Islander Voice to Parliament at the December meeting. In addition, State Council endorsed requesting the Commonwealth Government to ensure that Local Governments and local communities across WA are meaningfully engaged with on the issue. Finally, State Council resolved that an advocacy position in support of constitutional recognition would be developed. The proposed advocacy position is included in the State Council agenda for Zone and State Council consideration.

## **Elected Member Superannuation**

State Council resolved for WALGA to advocate for superannuation to be required to be paid to Elected Members of Local Governments in SAT Bands 1 and 2, and for payment to be optional for Local Governments in SAT Bands 3 and 4.

Several Advocacy Positions were updated by State Council in relation to Biosecurity, Aboriginal Cultural Heritage, and Coastal Planning.
