### 6.2 WALGA Regional State Council Meeting

At least once per year WALGA State Council meets in a regional location hosted by a Zone in conjunction with a Zone Forum and / or tour of local amenities, projects or points of interest.

It is proposed that the September 2019 Regional State Council meeting be hosted by the Gascoyne Zone.

Regional meetings afford State Council the opportunity to meet with Elected Members and senior officers from Local Governments within a region, to discuss issues of local and regional significance. They also allow State Councillors to meet with other regional groups of interest to gain a first-hand appreciation of the various issues confronting Local Governments in each region.

The last time that the Gascoyne Zone hosted the WALGA State Council was in 2009 in Exmouth.

It is proposed that the 2019 Regional State Council meeting be held over two days on Thursday 5 September and Friday 6 September.

Typically a Zone Forum would be held on the Thursday (5 September), to be followed by a dinner with Zone members, State Council and WALGA senior management. Then the State Council meeting would be held on the morning of Friday 6 September.

The requirements for a town to host the regional State Council meeting are:

- Ability to accommodate State Council and WALGA staff (35 rooms required);
- A venue for the Zone Forum and State Council meeting; and,
- A venue able to host dinner for the WALGA party and Zone members.

For a trip to the Gascoyne Zone, the WALGA group would travel to the Zone by plane using existing commercial services or chartering a plane if necessary. Timing of the Zone Forum, State Council meeting and other activities will be flexible depending on times of flights to and from the host town and the wishes of the hosting Zone.

In terms of cost, WALGA would be seeking a contribution from Zone members for catering for the Zone forum and dinner portions of the event on a per-head attended basis. WALGA would also be seeking use of Local Government facilities (if available) as a venue for the Zone forum and State Council meeting.

Discussion is sought regarding the venue for the regional State Council meeting. The Executive Officer will then liaise with the host Local Government and other Zone members to organise the 2019 regional State Council meeting and Zone forum.

That the 2019 regional State Council meeting be held in Shark Bay.
